

# Terms & Conditions

## THE CLUB

"The Club" shall be operated as a proprietary Club owned by The Angel Hotel Ltd, Chippenham, Wiltshire SN15 3HD, to be administered by the Manager for the time being of the hotel or by such other person or persons as the Hotel Owner (hereinafter referred to as the "owner") shall nominate.

## MEMBERSHIP

Persons wishing to become members of the Club must complete an official application form. Each application must be accompanied by the relevant entry fee which is at the time in force and the appropriate subscription. Absolute discretion is granted to the owner and the manager to reject any application for membership without ascribing any reason for doing so.

Membership is on a monthly or yearly continuous basis, unless otherwise stated. The owner or manager shall be under no obligation to renew or extend membership, but any renewal or extension shall be on condition that the member has and will continue to comply with any rules, regulations and conditions relating to membership. Where a joining fee is charged, this fee will not apply to membership renewals provided that the membership is continuous. If the membership lapses, or is terminated, any renewals will be deemed as a new membership to which the joining fee will apply.

Each member will be issued with a membership card which will remain the property of the owner and on termination of membership for whatever reason will be returnable to the owner on demand. A member will be required to produce a membership card on demand. A small charge will be incurred for lost membership cards.

Membership is non-transferable. Temporary membership is offered to hotel residents during their stay at the hotel.

On every visit to the club, members and residents must sign in and out at the club reception desk.

## HOURS OF OPENING

The owner shall be entitled at any time and for any period to vary the times at which the facilities, or any of them are available if the facilities are required in connection with the general hotel operations of the owner, or by reason of any repairs, alterations or maintenance to the club or hotel facilities. Although the owner shall be entitled to take such steps without prior notice the owner will seek to notify members in advance.

## CLUB STAFFING

The club will always not be staffed, and the times of staffing may vary at the discretion of the owner or manager. Staffing in no way implies supervision and all members are responsible for their own safety and that of their guests and children.

## GUESTS

Members may bring guests into the club. Charges are applicable per guest per day and are subject to increase without prior notice. Charges are payable in advance at the main hotel reception desk. Only members over the age of 18 may introduce guests, and a member must always accompany his or her guests in the club. No more than 2 guests per member may be admitted on any one day, and all guests must be signed in and out of the club. Guests are admitted to the club on the condition that they observe the code of conduct.

## CHILDREN

Children under the age of 16 will only be admitted to the club facilities if they are accompanied by an adult who always accepts full responsibility for their supervision. In the interest of health and safety, children under the age of 16 are not permitted to use any of the fitness equipment.

## SMOKING

Smoking is not permitted in the Club

## ANIMALS

No animals, other than guide dogs are permitted in the club. Guide Dogs are not permitted to enter the swimming pool

## CLOTHING

Members and their guests are requested to dress in a manner appropriate to the sporting activity being engaged in. Swimwear is not permitted in the Hotel buildings. No outdoor shoes may be worn in the pool area. Gym Shoes must be worn in the gymnasium area

## ALCOHOL AND DRUGS

No member or guest may use the facilities whilst under the influence of alcohol or drugs. The owner or manager may at his discretion refuse access to the club to any member or guests who in his sole opinion is so influenced

## HOTEL FACILITIES

Members are entitled to a 20% discount on food purchased in the hotel restaurant or bar for up to a maximum of six persons at any one time. A discount of 20% will be given on accommodation booked by a member up to a maximum of six nights in any one year. Subject to availability.

## TERMINATION OF MEMBERSHIP

Any member who misuses the Club facilities or who acts in a way which constitutes a safety hazard or interferes with the enjoyment of other members will have their membership terminated immediately. Moreover, the owner reserves the right to terminate the membership of and member at any time, without notice, at their sole discretion. If the owner terminates the membership of any individual enrolled under joint membership, then the membership of all other persons enrolled under that membership will automatically be terminated at the same time. In the event of membership being terminated by the owner under this regulation the member/s covered will receive a refund of the subscription in proportion to the unexpired period of their membership.

If any member wishes to terminate their membership before it would normally expire, any refund of subscription shall be at the sole discretion of the owner. No application for refund will be considered where the unexpired period of membership is less than one calendar month.

If the owner considers it necessary to terminate the permission extended to the guest of any member to use the club facilities, no refund of the admission charge in respect of that guest will be paid.

## GYMNASIUM

Use of the gymnasium is not permitted without prior instruction on the correct operation of the equipment. No training program will be suggested or provided by the owner, his employees or representatives. Swimwear will not be permitted under any circumstances as acceptable clothing whilst using the gymnasium equipment.

## SWIMMING POOL

In the interest of hygiene, members are requested to shower before using the pool.

Non swimmers and learners must be supervised by a responsible adult.

No Jumping or diving into the swimming pool. No jumping or running around the pool area.

The use of equipment such as flippers, lilos, mask and snorkel, balls etc are prohibited. This does not apply to inflatable armbands or other support for non-swimmers.

## VARIATIONS

The owner reserves the right to amend and add to these rules and regulations as they see fit, and members shall observe any amend or additional rules and regulation so made.

## LIABILITY

The owner accepts no liability for any illness or injury resulting from the use of the club facilities by members, guests or hotel residents. Equally the owner accepts no liability for illness or injury from over exertion, precipitation or aggravation of a medical condition caused by such use, all persons who use the club facilities do so on the expressed basis that the use is at their own risk. It is strongly recommended that patrons seek medical advice before undertaking any exercise in the club.

The owner will only accept liability in respect to the loss or damage to the property of members or guests, or for personal injury to, or death of any member or guest where such event arises solely from the wilful act, neglect or default of the owner or any of his employees or agents.

Members are required to use the club and its facilities in a proper and prudent manner. The club will not be responsible for any injury or loss to any member or guest arising from negligence, default other wrongful act of any member. The club reserves the right to require any member to make good or indemnify the club against any damage or destruction of club facilities caused by negligence, default of wrongful act of such member.

Member, their guests and hotel residents are responsible for making their own insurance arrangements in respect of injuries suffered by them or caused by them to any third party.

Lockers are provided in the changing rooms for use by members and guests. The owner cannot accept responsibility for loss of or damage to property belonging to any member or guest. The owner is particular accepts no responsibility for loss of or damage to any valuables while on the owner's premises (including valuables left in vehicles)

Each member is responsible for making their guests aware of the club rules

Any dispute which may arise with regard to the interpretation of these rules shall be determined by the owner/manager, whose decision shall be final and binding upon all members.

By their membership, members, guests and hotel residents must accept and agree to be bound by the rules and regulations of the club. Patrons may be asked to leave the premises or be refused entry if any breach of these club rules and regulations is noted
